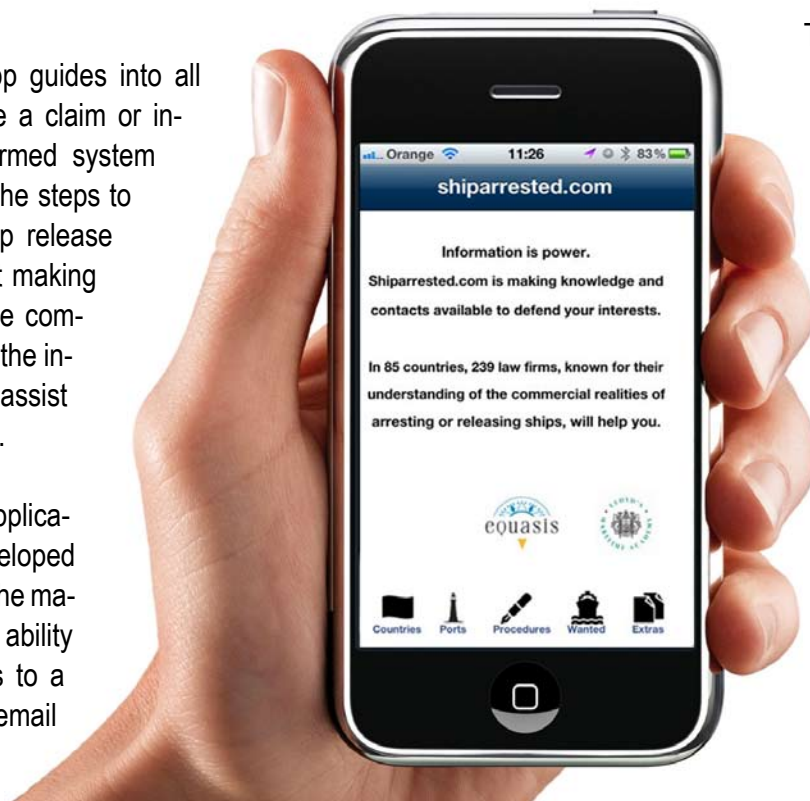
Is delighted to announce the launch of a first of a kind mobile application for the maritime industry - an updated version of our highly successful platform www.shiparrested.com!
