

Problem: Barge "Jura":

On 26 July 2024, the Parties signed the handover-acceptance act, by which Raduga confirmed that it had accepted and approved the works performed by Netaman under the Contract, and that it had no claims regarding the timing or quality of the completed works.

The Parties do not dispute that after the handover of the work performed under the Contract, it was discovered on 30 July 2024 that the dimensions of the completed work were inconsistent with the drawings submitted together with Raduga's order, and Netaman proposed to Raduga, pursuant to § 646(1) of the Estonian Law of Obligations Act, to rectify the completed work. Likewise, there is no dispute that Raduga offered Netaman two options for rectifying the works, and on 2 August 2024, Netaman agreed with option 1 proposed by Raduga and immediately commenced rectification of the work performed under the Contract.

#### The ORION "arrest":

Therefore, pursuant to clause 2.4.4. of the ORION Contract and Article 110 (1) of the Estonian Law of Obligations Act, Netaman has the right to

Due to the fact that

Raduga has violated the terms of Addendum No 8 to the ALTAIR Contract, then pursuant to Article 111 (1) and Article 111 (4) of the Law of Obligations Act Netaman may detain the Vessel also for the payments the due date of which have not arrived pursuant Addendum No 8 to the ALTAIR Contract, because otherwise these obligations would remain unsecured.

Netaman explains for the avoidance of doubt, that exercising its rights arising from the ORION Contract and Estonian Law of Obligations Act does not constitute arrest of the Vessel and it is irrelevant if Netaman can arrest the Vessel pursuant to international conventions. Pursuant to Article 8 (3) of the International Convention on the Arrest of Ships "This Convention does not affect any rights or powers vested in any Government or its departments, or in any public authority, or in any dock or harbour authority, under any international convention or <u>under any domestic law or</u> regulation, to detain or otherwise prevent from sailing any ship within their jurisdiction."

The ORION "arrest":

Under cover of the night, the vessel leaves the port, without performing sea trials and without signing any documents about repairs, which void the warranty of the works.

#### The claim of Raduga Shipping Limited:

A repeated contract for work was concluded between the Client and the Contractor for the construction of the Platform. The Contractor materially breached obligations arising from the Work Contract, including the fact that the subject of the contract did not comply with the agreed contractual terms and conditions. Furthermore, the Contractor was delayed in delivering the Platform during the period from 02.07.2024 to 21.08.2024, resulting in substantial financial losses for the Client, including <u>lost profits, totaling EUR 477,643.69</u>. Additionally, the Client demands the payment of a contractual penalty from the Contractor in the amount of EUR 16,780. The Client hereby submits an offsetting statement to the Contractor, as a result of which mutual claims of the parties have been offset in the overlapping amount of EUR 116,268.57. Following the offset, the Contractor no longer holds any monetary claims against the Client.

#### Arrest of RADUGA ALTAIR:

As a total surprise to Netaman Reapair Group OÜ, RADUGA ALTAIR arrives in the Port of Paldiski and at the request of Netaman Reapair Group OÜ the vessel is arrested for the upaid 116 268,57 EUR, the deposit to release the arrest is set at 160 000 EUR. The deposit is paid, the vessel leaves the port.

Raduga Shipping Limited challanges the arrest, basing it on their counter-claim and that there is no claim. Nothing about ownership of the vessel is mentioned.

Netaman object the appeal and Tallinn Circuit Court (second instance court upholds the arrest.

Raduga Shipping Limited challanges the arrest at the National Court (highest court) claiming that the owner of the vessel is Raduga Shipping & Barges Limited and the vessel could therefore not be arrested. National Court accepts the case for processing and asks for observations of Nataman Repair Group OÜ.
